Flight Students/W. O. C. students – All Flight Students will receive a new PHA as part of the upcoming Flight Physical

Complete the Member portion of the PHA (DD Form 30204) online **prior** to the Flight Physical appointment.

Must be on a .mil site in order to complete (Kiosk located at the front entrance of Lyster Army Health Clinic, Unit Computer, or Post Library).

<u>ALL other personnel</u> - complete member portion of the PHA online and schedule an appointment with your PCM to be seen face-to-face or VIPRR Hotline (virtually):

Be sure to save the form; otherwise Provider will not be able to access form at appointment time

If you are RED for any of the following reasons:

HIV Blood Draw: Lab is a walk-in service at LAHC, 0730-1530

DNA: Lab is a walk-in service at LAHC, 0730-1530

Immunization(s): Immunization Clinic is a walk-in service, 0730-1530 (All students arriving from West Point will need to go to the Immunization Clinic; Red or Green)

Vision and Hearing: *Flight* and *W. O. C.* Students will be getting a Flight Physical and PHA soon. No need to go to Eye/Ear Clinic because this will be covered as part of the Flight Physical/PHA visit.

All other personnel Red for hearing and vision will schedule an appointment at 334-255-7185

MRC	Description / Most Serious IMR Deficiencies	
MRC 1	Fully Medically Ready. Includes Temporary Profiles ≤ 7 days in length.	Deployable
MRC 2	Partially Medically Ready. Soldier is deficient in one of the following: Hearing Readiness Class 4 (current within 13 months) Vision Readiness Class 4 (current within 15 months) DNA (Drawn, on file with DoD Repository) HIV (Drawn, validated with DoD Repository) Immunizations current/ valid exception (HepA, HepB, TDA, TDaP, MMR, polio, varicella, (influenza seasonal) Individual Medical Equipment (1 protective mask insert, 2pr eye glasses, 1 pr MCEP-I, medical warning tag, hearing aid w/batteries) Temporary profiles between 8 to 30 days	Deployable
MRC 3	Not Medically Ready. Soldier has one of the following deployment-limiting (DL) conditions: DL1: Temp Profile > 30 days to include VRC 3 or HRC 3 profiled conditions DL2: Dental Readiness Class 3 Deployable DL3: Pregnancy and post-partum DL4: Perm profile indicating MAR2 action needed (AR 635-40) DL5: Perm profile indicating MEB action needed (AR 40-400) DL6: Perm profile indicating a non-duty related action needed (PEB) DL7: Perm profile – includes P3 with deployment /assignment restriction code (F,V, X) and P2 with (F, V) code	DL1/2 Deployable per Commander DL3-7 Non- Deployable
MRC 4	Medical Readiness Indeterminate. Soldiers Medical Readiness status is unknown or Soldier is deficient in one of the following: Periodic Health Assessment (current within 15 months) Dental Readiness Class 4 (current within 15 months)	Deployable per Commander
